- Provide direct therapy services in homes, schools, community settings, or program facilities.
- Monitor client progress and adjust intervention plans as required.
- Support and coach parents and caregivers with strategies to reinforce therapy goals at home.
- Collaborate with multidisciplinary team members including health staff, educators, support workers, and community partners.
- Provide consultation and recommendations to teachers, daycare providers, and program staff.
- Maintain accurate clinical documentation, reports, and treatment notes in accordance with professional standards.
